COURSE BRIEF:

This exciting course is designed to ensure every student is trained to become a skilled, knowledgeable and confident artist to practice the skill of eyebrow procedures using the ancient technique, originating from Asia, of embroidery microblading.

SKILL LEVEL: ● ● ●

This course is designed for beginners, however, students are required to have a beauty background, including eyebrow shaping, skin treatments or hairdressing and some A&P knowledge.

COURSE OVERVIEW:

- Pre-course - Study to be completed at home
- Day 1 - Theory & demonstration
- Day 2 - Practical work (2 models required)
- Post-course - Student to carry out 5 complete microblading treatment case studies from home
- Assessment day – student to present portfolio of case study evidence, then perform a complete live microblading treatment (1 model required)

IMPORTANT INFO:

Students must be 18+. Please bring lunch.

MODELS MUST:

- Be over 18 years in age
- Not be pregnant or breast feeding
- Not about to visit any hot climates or have a recent suntan
- Not have Botox or fillers around brow area
- Have no cuts or abrasions in or close to brow area
- Complete a patch test prior to treatment

ADDITIONAL INFO:

LICENSING

Microblading is classified as a 'medical' treatment and needs to be carried out on licenced premises. This special licence can be obtained from your local council who will visit and inspect the premises/treatment area. Hygiene and sterilisation are paramount and are taught in line with the majority of local council regulations. However, some councils require the use of fully disposable blades or specific autoclaves. Please check with your council what their requirements are. There will be a fee for this licence and each district council has its own requirements and cost, so check with your local authority prior to booking this course. These treatments CANNOT be carried out on a mobile basis - only at premises that hold a licence.

INSURANCE

Not all insurance companies cover this procedure, so please check with your own insurance company first. Being classed as 'medical', there will be an extra premium to added on to existing insurance. This is an ABT accredited course where insurance is given.

CASE STUDIES

Certificates will not be issued until all 5 case studies have been completed and the assessment has been passed to the satisfaction of the assessor. Students must complete this within 3 months of taking the course.

EQUIPMENT

The kit included in the course contains enough pigments, needles, tool, caliper, sticky rulers, pigment caps, pencil to carry out at least 5 case studies. Additional items may be required to be purchased in order to complete your case studies.
